Security Service Update

As you may recall, the MHACC hired F-Dub security service on a trial basis from July 2021- Dec 2021 in response to the increase in criminal activity in Marine Hills. The security service randomly patrolled the neighborhood 5 days a week and sent reports after each patrol to the MHACC for review. After that trial period concluded, data was collected from communitycrimemap.com which is a resource given to us by the Federal Way Police Department as a way to research crime statistics in our neighborhood. While not an exact science, data shows that prior to the security service, total criminal activity in Marine Hills was up 110% vs the same period the year prior, and residential burglary was up 75%. After the security service was instated, total criminal activity fell to 12% vs the same period the year prior and residential burglary was down 50%. Given this and the survey results described below, the MHACC has voted to reinstate this service and we ask for your support of \$50/year in dues.





Security Service Update



Headline: Marine Hills Criminal events have shown decline in trend since implementing F-Dub security service with a significant decrease in residential burglary events.



110% vs the same period in 2020. Residential burglary was up 75% vs the same period in 2020. During the security service trial period (Jul-Dec 2021) trends declined to +12% for all criminal activity down -50% for residential burglary.

Security Service Survey Results

Community safety is everyone's concern, and MHACC is working to help keep Marine Hills safe and secure. We recently sent out a survey via NextDoor asking for your feedback on the security service. A very big shout out and thanks to all of the 81 respondents. Here's what they said.

- 85% of the residents were aware that MHACC had hired a security service •
- 93% of the residents are supportive of a security service patrolling Marine Hills •
 - 71% very supportive and 23% somewhat supportive
- 83% felt the security service has been effective
 - 30% very effective and 53% somewhat effective
- 70% of residents are likely to increase their dues contribution from \$30 to \$50 to support the service •
 - 22% said maybe, and want to learn more

Bottom line: 1) With over 90% of respondents supportive of keeping the security patrols in our neighborhood and given the crime trend more broadly, the MHACC voted to continue the service. 2) An increase in your annual dues from \$30/ year to at least \$50/year will help cover the cost of the security services, contribute to the safety of our community, and give us all more peace of mind. Marine Hills Dues

Thank you, neighbors! For 2021, thanks to your generous support, we collected 22% more dues than 2020 and had 208 residences contribute vs 185 in 2020. We also came in under our budgeted expenses by 21%. That allowed us to roll over some budget to 2022 to fund repairs at the 9th place entrance and extend the Marine Hills security service trial period.

There are approximately 525 residences in our neighborhood and we would like to see everyone contributing! Please see the charts below to better understand the MHACC expenditures for 2021 and budgeted expenditures for 2022. The added expense of the investment in security services benefits everyone, and we need your support to keep Marine Hills a beautiful, welcoming, and safe community.
