
It's that time of year again to ask for your yearly neighborhood MHACC dues of \$30 per household.

Last year we were able to raise over \$7,500 which was nearly a 30% increase over the prior year. We had 185 residences contribute which was a 41% increase over 2019. And many residents contributed more than the \$30. Thank you all!

Your dues contributions to the MHACC allow us to:

- Keep our neighborhood safe through partnerships with SafeCity.
- Keep our entrances well maintained by funding supplies for our volunteer entrance committee.
- Keep our property values intact through covenant enforcement which reinforces well maintained properties and protects our treasured views.

- Send out regular newsletters to keep the neighborhood informed on important topics that affect us all.

Get to know Marine Hills and the MHACC

History of Marine Hills Subdivision and the MHACC (Part 1)


Our beautiful community of Marine Hills. The development of the Marine Hills Subdivision (a residential addition) in King County, Washington (now within the City of Federal Way) occurred progressively over a period of years from 1956 to 1973 by the filing of Plats Nos. 1 through 12 and 14 through 17 plus Marine Hills West (18); Marine Hills East (19); Marine Hills Plat #20 (Formerly Redondo View Estates No. 1 & 2); Marine Hills No 21 (Formerly Marlbrook #2); and Marine Hills Plat #22 (Formerly Marine Heights Subdivision). The filings of each plat, accompanied by Protective Covenants, also referred to as Reservations, Covenants, and Restrictions (hereinafter referred to as "Covenants"), to run with the land were duly recorded in the King County records.

Our Marine Hills Architectural Control Committee. The Covenants for each plat contained the provisions for the establishment of a Marine Hills Architectural Control Committee (hereinafter known as the "MHACC" or "the Committee") to oversee implementation. In order to operate in a businesslike manner, to maintain continuity, and to provide consistency of policy, the Committee adopted a set of Guidelines to facilitate its operations, herein referred to as The MHACC Operating Guidelines. The MHACC was instituted to interpret, mediate, and support the reservations, restrictions, and covenants of the Marine Hills Subdivision. This includes monitoring resident properties within the Subdivision for adherence to the covenants. Specific activities of the Committee include, but are not limited, to:

- 1. Review and approval of plot plans, external designs including heights, and finishes of all structures.
- 2. Interpretation of the Covenants.
- 3. Investigation of disputes between property owners, followed by recommendations for settlement.
- 4. Maintenance of entries at 11th Place South and 9th Place South and the strip along Dash Point Road.
- 5. Application of Procedures for Resolution of Disputes as defined in the Operating Guidelines

MHACC Volunteers. The duty of the all-volunteer Marine Hills Architectural Control Committee is to interpret and enforce the 21 covenants applicable to our neighborhood's 525 residences. This is different than the typical regulatory powers of a Homeowners Association (HOA), however both the covenants and the committee "have teeth". The decisions rendered by the committee have, in the past, been used in legal proceedings and given weight in the matter before the courts. MHACC is an all-volunteer committee and is looking for volunteers!

Marine Hill Residents. The duty and responsibilities of Marine Hills residents are to know and adhere to plat covenants. The covenants benefit the entire Marine Hills community and just as you are counting on your neighbors to maintain the standards of the neighborhood, your neighbors are counting on you. Please review your particular plat's covenants or the ones of adjoining residences. You can obtain a copy of any covenant on the Marine Hills Architectural Control Committee website. Together we enjoy a very special community

We look forward to having the 9th Pl camera up and running very soon!

A big thank you to everyone who contributed to the Safe City fundraiser and for your annual dues contributions. Through that we were able fully fund the replacement cameras. You are all part of helping make our neighborhood a safer place to live.
